The permission accorded in para 1 above is subject to the following conditions.

- The Management should run the College without any Government Grant till such time as the Government are willing or in a position to sanction grant-in-aid to any case not earlier than 5 years from the data of inception of the college and the Question of admitting to aid may be considered in future, in any year, after 5 years when the Government are in apposition to do so depending on the budget provision and other relevant factors.
- b) The Management should deposit Rupeer Twenty Five Thousand immediately, and a further sum of Rs.25,000-00 with in a six months from the date of opening of the College under the Joint account of the Director of Higner Education and the Chairman of the College Committee. The Amount stipulated to in addition to the corpus fund to be deposited according to the Instructions of the University concerned.
- the University is regard to accommodation, equipment, staff playground, Library etc., and it should have nothing in common on with the existing Junior College.
- d) The College may collect tuition fees as decided by the Government.
- e) The Committee should allow for concessions etc., to Scheduled Castes and Scheduled Tribes and other Backward Classes as per the rules, inforce, and the amount covered by the concession will be reimbursed by the Government subject to the budget provision available in this regard, and according to the rules prescribed by the Government from time to time.
- f) The Management should provide temporary accommodation to locate the College on private pucca Buildings, as early as possible, and also to provide 30-40 acars of land for the College.
- g) The Management should take necessary action to obtained affiliation of the University concerned.
 - The Management should fullow the rules issued by Government from time to time inregard to reservation for Scheduled Custes, Scheduled Tribes and other Bachward Classes in respect of admissions and the amployment of staff.
- 1) The College shall open with 1st year Degres Course in B.A., and B.Com.,

J) lelugu should be the medium of instruction in the course
