Order

In the G.O first read above, orders were issued for  
taking over of 13 colleges functioning under the erstwhile  
Chintalapati Bapi Raju Dharma Samsthas ( i.e. Five Junior  
Colleges, Five Degree and Three Oriental Colleges) by the  
Government with immediate effect. In the G.O second read  
above orders issued for payment of compensation to the  
said Samastha and for physically taking over of the said  
college.

In the reference third read above, the Commissioner  
of Collegiate Education reported that he has issued instru-  
ctions to the Regional Joint Director for Higher Education.,  
Rajahmundry for Physically taken over of the said colleges  
in West Godavari and furnish his report. Accordingly, the  
Regional Joint Director for Higher Education, Rajahmundry  
taken over the five Degree colleges viz., 1.RRDS College,  
Bhimavaram 2.Ch.V.P.M.R.College,Ganapavaram, 3 SAS College.,  
Narayana puram 4.CSTS Kalasala, Jangareddigudem and 5.V.V.  
Giri Kalasala, Dumpagadapa on 9.4.1997. The Commissioner  
of Collegiate Education also reported that the above said  
five colleges were taken over by the Government and the staff  
working in those colleges have to be paid salaries from Govt.  
head of account under non-plan and requested the Government  
for changing of the head of Account from grant-in-aid head to  
Government head under non-plan and requested for issue of  
suitable orders in the matter.

The Government after careful examination of the proposal  
of the Commissioner of Collegiate Education hereby direct that  
the salaries of the Staff working in the five Degree colleges  
of erstwhile Sri Chintalapati Bapiraju Dharma Samstha which  
were physically taken over by the Regional Joint Director  
for Higher Education, Rajahmundry be met from the following  
head of Account by transfer of necessary provision available  
under grant-in-aid to aided colleges to the Government Colleges  
in the Non-plan budget estimates for the current financial  
year 1997-98.

- 2202 - General Education.,
- 03 - University and Higher Education.,
- MH-103- Government Colleges and Institutions.,
- SH-07 - Government Degree colleges for Men.,
- 010 - Salaries(Non-Plan).

The Commissioner of Collegiate Education is requested to submit necessary re-appropriate proposal to Finance and Planning Department for making provision according in the revised estimates at the appropriate time. Pending provision of amount the Principals of the Colleges shall draw and disburse salaries to the staff of their colleges., from the Head of Account mentioned above.
