The Conveners noted in Col.3 of the annexure should submit the consolidated reports keeping with them individual checking reports of their committee members. Necessary certificate of verification in the respective Departmental Register has to be recorded and signed by the Conveners and other members of committee with dates. The verification report as appended has to be recorded in the concerned Registers and the countersignatures of the Principal must be obtained as required under articles 140 APFC ie, articles purchases should be verified with reference to the vouchers / entries made in the Accession Registers and Stock Registers NMSR / SSR. If the maintenance of Stock Register is not proper the fact should be reported. Verification between, the book balance and the stock entry with reference to the vouchers and the bills should be separately pointed out. Missing in accounting i.e., addition, subtraction, duplicated entries should be carefully noted. Vouchers numbers have to be noted against the entry. Loss of Stores / Sectional Libraries if any should be properly reported duly fixing the responsibility. List of books to be condemned / written off and to be repaired etc should be separately prepared for Government and Non Government funds. Entries which were made during the year under reference have to be checked with reference to the invoice and stock entry certificate.

The Conveners are requested to submit the separate list of articles - books to be condemned with utmost care in the following forms together with the prescribed certificate under Articles 140 of APFC Vol-1. The particulars should be shown in the form prescribed separately in respect of articles / books purchased from (i) Government funds ii) Special fee (P.D / A.C) and iii) U.G.C Grants. Certified that I have personally satisfied myself that each item recommended to write off in the statement has become unserviceable in the ordinary course through proper usage, by fair wear and tear.

Separate lists should be made in respect of the Articles which should be repaired and can be put to further usage along with the list of articles which can be condemned and auctioned.

All the concerned are requested to keep ready Register etc., and render necessary co-operation to the verification authorities concerned, so that there may not be any complaints in this regard. The checking is to be made for the purchases up to 31.03.2021.

The Conveners and members are personally responsible for the verification of all the stock, assets and immovable properties of the college. Hence they are requested to bestow personal attention in the verification process and plug out the discrepancies if any.
